

# *2012 Mid America Volleyball Open Challenge*

To all Mid America Volleyball Open Challenge participants:

We are very pleased to have you in our annual junior volleyball tournament. This packet should contain all of the information you need to compete in this year's event.

Please remind all parents, players and coaches - **No outside food or drinks** are allowed into any of the playing facilities. **Exceptions:** Water Bottles for players.

Also, there will be admission to all venues. Admission will be \$4 for adults, \$3 for senior citizens and students, children 6 and under are free.

## **Warm-Up Procedures**

Both teams will share the court for 2 minutes (keep balls on own side).

Each team will then get the entire court for 4 minutes. Serving must be a part of each team's own court time.

The team that elects to serve first gets the court first for individual time.

This procedure will be for pool-play and playoffs.

## **Pool-Play Schedule and Format**

The following is a schedule of pool-play.

In all pools, except for 4P1, matches will be best 2 of 3 sets with sets 1 & 2 being 25 point sets. All deciding sets will be 15 point sets. All sets have no cap and must be won by a minimum 2 point margin.

In Pool 4P1, all 3 sets of each match will be played to 25 points. All sets have no cap and must be won by a minimum 2 point margin.

The 3-team pools in the 12s and 17s division will have one round of pool play and then a crossover. Bracket play will then follow the crossover matches.

The 3-team pools in the 13s division will have one round of pool play and then a repooling. There will not be a crossover match after the 1<sup>st</sup> round of pool play. Instead there will be a reseeding for a 2<sup>nd</sup> round of pool play to be played immediately after the 1<sup>st</sup> round of pool play.

In the 5-team pools in the 15s and 18s division, 2 matches will be played simultaneously on 2 courts. The team not playing will be required to provide a down ref, scorekeeping team and linesmen for both courts.

In pools 5P2 and 5P3, all teams will play a Challenge Match on Sunday morning, and then go directly to bracket play.

## **Playoff Scenarios:**

### ***3-way ties***

Only 3-way ties to advance to the Gold Playoffs will be settled in the following format:

- Teams will be seeded in the following order:
  - Set winning percentage
  - Point percentage (team total points / team total points given up)
  - Coin toss

### **FOR TWO TEAMS ADVANCING**

- The top seeded team will be awarded the first position.
- The two remaining teams will play one 15 point set with no-cap for the remaining spot. The top seeded team will referee that set.

### **FOR ONE TEAM ADVANCING**

- The top seeded team will get a bye and ref the first playoff set between the 2<sup>nd</sup> and 3<sup>rd</sup> seeded teams.
- The winner of the first playoff set will play the top seeded team, with the winner advancing to Gold.
  - The loser of the first playoff set will referee the second playoff set.

### ***2-way ties***

All 2-way ties will be resolved by head-to-head results.

## **Penalties:**

### ***Missed refereeing assignment:***

- If you do not show up for your refereeing assignment when it is time for the match to begin, you will be assessed a 5 point penalty for each set in your next match. This will be in effect no matter if your next match is in pool play or bracket play.
  - If your missed assignment is in bracket play and you do not have a next match in which the penalty can be assessed, you will be immediately reported to your Club Director and Region Commissioner. Disciplinary action, at the Tournament Director's discretion, will also be taken for the next MidAmerica Volleyball Association event in which you participate.
- If you do not show up for your refereeing assignment in a playoff (from pool play), you will forfeit your match and drop to the lowest playoff position.
  - If there 3 are teams in the playoff, the forfeiting team will finish last of the 3 seeded teams.
  - This will then leave 2 teams, and there will be no playoff between them. They will advance based on their head-to-head results in pool play.

### ***Late for playing a match:***

If you are late for playing a match, when it is time for the match to begin, you will forfeit the first set. If after 10 minutes, you do not show up for the second set, you will forfeit the second set, and therefore forfeit your match.

***For any and all penalties, you will be reported to your respective Club Director and Region Commissioner for your violations of tournament play.***

**From I-264:**      Take Exit 19A to merge onto I-64 East towards Lexington. Go to Exit 17 / Blankenbaker Pkwy. – Go right on Blankenbaker Pkwy to the first light. Turn right onto Bluegrass Pkwy. (McDonald’s on the corner). Follow Bluegrass Pkwy to the stop light at Watterson Trail. Turn left and go approx 1/4 mile. Look for a white sign on the right that says “Center of Bluegrass”. Take a right and follow to the parking lot.

Drive across the freeway and take the 2<sup>nd</sup> right onto Stanley Gault Parkway. US Basketball Academy is ½ mile on the right.

**Brandeis -**      Located directly across Watterson Trail.

**Mako Electronics** – Located Behind MidAmerica. From MidAmerica, exit right onto Watterson Trail. Take first right onto Bunsen. Cross the railroad track and take the first road on right, Production Rd. Smurfit Stone will be on the right. You will be able to see the back of MidAmerica from parking lot. Proceed to the grass path between Smurfit & MidAmerica. Go across railroad tracks to MidAmerica parking lot.

## There is a new Libero rule for the upcoming season.

From the Domestic Competition Regulations (rule book)

19.1.1 Each team has the right to designate from the list of players up to two (2) specialized defensive players: Liberos

19.1.2 All Liberos must be recorded on the score sheet before the match in the special lines reserved for this.

19.1.3 One Libero designated by the coach before the start of the match will be the starting Libero. The Libero on court is the Acting Libero. If there is another Libero, he/she will act as the second Libero.

19.1.4 Only one Libero may be on court at any time.

19.1.5 The Libero cannot be either team captain or game captain at the same time as performing the Libero function.

### In a USAV event

This new rule means you may designate up to 2 Liberos.

1. You may designate 2 liberos, only one, or none but any decision is for the entire match.
2. **The libero may not serve.**

### In Pioneer Region sanctioned events

1. The coach may designate 2 liberos, only one, or none and may change the libero(s) every set

2. The libero may serve. **If you have 2 liberos they may only serve in one position of the service rotation.**

Ex: Libero #1 goes in to serve for the player in service position #3. That is now the only position that either libero will now be allowed to serve in. This means that there would be 3 players that could legally serve in position #3, Libero #1, Libero #2 and the player in position #3. Yes and also if you wanted to make a substitution for player in position #3 that player could serve also.

REMEMBER THIS IS ONLY FOR EVENTS IN THE PIONEER REGION. You will have to check the rules when you go out of region to play. Also any Nationally sanctioned USAV event, such as the qualifiers, the liberos will be for the match and will not be allowed to serve.

## For the Pioneer Region, the libero is allowed to serve.

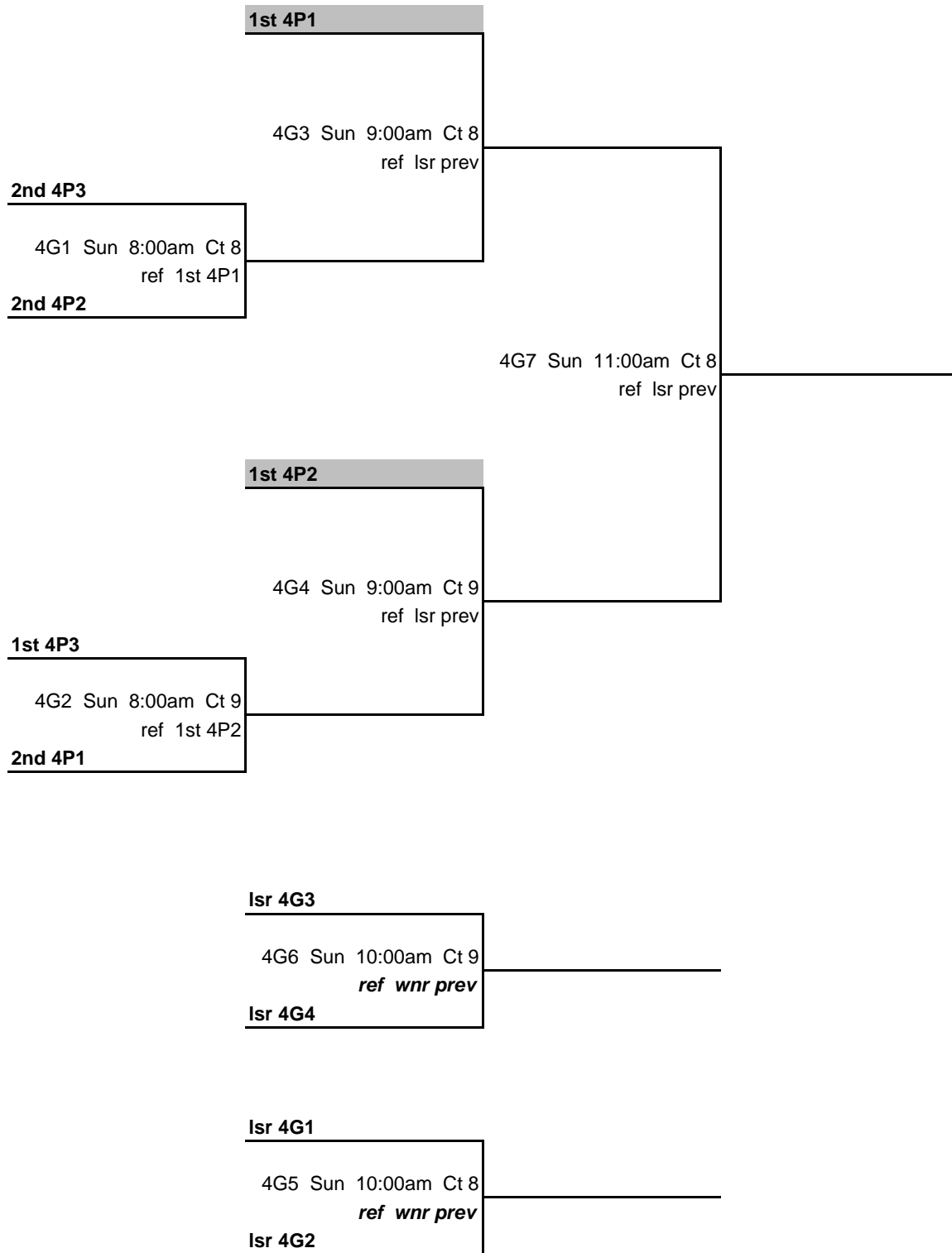

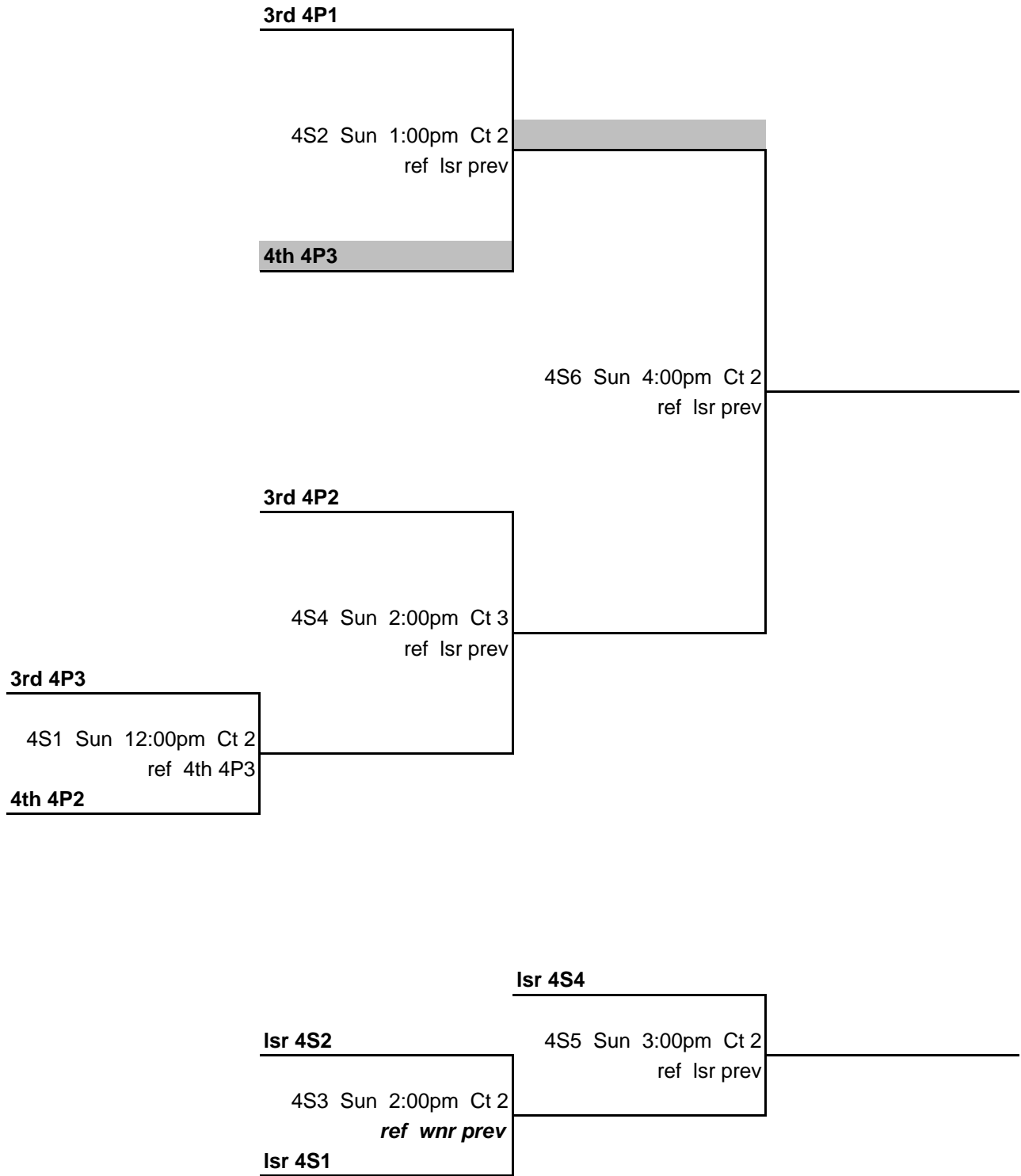

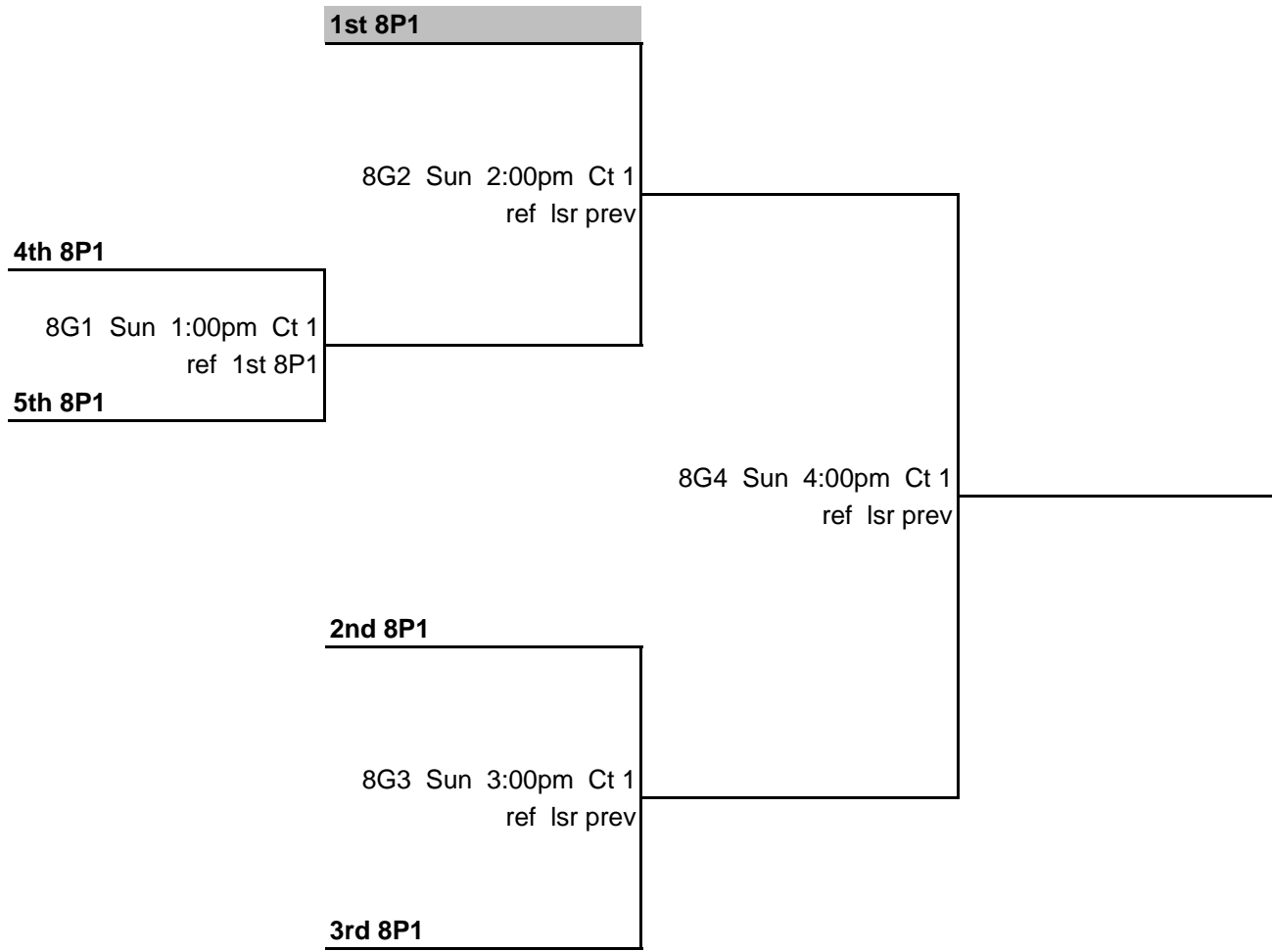
